ORDER MEMORIALIZING STATUS HEARING

This matter came before the Court on September 27, 2010 for a Status Hearing.

Jose Baez and Cheney Mason were present for the defense; Linda Drane Burdick and Jeff Ashton were present for the state.

It is hereby ORDERED AND ADJUDGED:

1. The deadline for the defense to complete the depositions of the remaining state expert witnesses (Bellard, Stenger, Rickenbach, Moore, Cawn, Bradley, Darnell, Gireaux, and Haskell) is extended to November 19, 2010.

2. Review of the evidence by any defense expert witnesses shall be completed no later than October 31, 2010.

3. All defense expert witnesses shall be listed by November 30, 2010.

4. The depositions of all law enforcement experts shall be completed by October 31, 2010.

5. By October 18, 2010 at noon, the parties shall submit to the Court an agreed


upon list of the names of ordinary witnesses (not expert witnesses or law enforcement officers) who did not appear on the witness lists until after May 24, 2010. Defense shall have until December 31, 2010 to depose the witnesses listed on the agreed upon list.

6. The deadline for the defense to list all penalty phase witnesses is November 30, 2010.

7. The Motion to Test for DNA Evidence filed on September 27, 2010 shall be addressed in a separate Order.

8. The parties shall coordinate a hearing time to address the defense motions relating to Roy Kronk. The state is not required to file a written response.
