ORDER MEMORIALIZING STATUS HEARING

This matter came to before the Court on August 30, 2010 for a Status Hearing.

Jose Baez and Cheney Mason were present for the defense; Linda Drane Burdick, Jeff Ashton, and Frank George were present for the state.

It is hereby ORDERED AND ADJUDGED:

1. When a Motion is filed, it must be scheduled for a hearing and heard within 15 days of the date of filing. Otherwise, it will be dismissed without prejudice.
2. The parties are reminded of the deadlines specified in the Second Amended Order Setting Discovery, Motion, and Hearing Deadlines and Trial Date, filed September 2, 2010.
3. A Supplemental State Witness List and an Amended Defense Witness List were filed on August 30, 2010 in compliance with paragraph 3 of the Amended Order Setting Discovery, Motion, and Hearing Deadlines and Trial Date, filed May 7, 2010. While the parties must abide by the deadlines referenced above, the Court will make *limited*


exceptions to extend the time period for witnesses newly disclosed on the final lists and not previously known.

4. The parties are reminded that if they cannot work out schedules for depositions, the Court will set the schedule, and the times will include evenings and weekends.

5. The Court provided the parties with a list of motions and the parties are directed to respond by September 20, 2010, indicating which motions have been rendered moot and which motions need to be set for a hearing or addressed at a later date. Thereafter, the Court will issue an order dismissing all motions that are moot.

6. Jury selection begins on May 9, 2011, and opening statements will begin on May 16, 2011.
