**RESPONSE TO COURT'S ORDER FOR DEPOSITION SCHEDULE**

COMES NOW the Defendant, CASEY MARIE ANTHONY, by and through her attorneys JOSE A. BAEZ, and J. CHENEY MASON submits this proposed deposition schedule and in support thereof states the following:

1. The State of Florida has filed a witness list of over 250 witnesses. Presently 36 of those witnesses have been deposed. On April 30<sup>th</sup> 2010, Assistant State Attorney Linda Drane Burdick represented to this Honorable Court that she believes the approximately 60 more witnesses may be deposed in this matter.
2. In the spirit of cooperation the Defense on May 5, 2010 submitted a list of 86 witnesses that required clarification as to the witnesses involvement in this matter. The State has graciously agreed to review this list and respond to the Defense with either corresponding page numbers in the discovery or a brief description of the respective witnesses possible testimony.
3. With over 14,000 pages of discovery and recent hearings, the State has not had the opportunity to complete this task. The Defense believes that the State is proceeding in good faith and has no evidence that would leave one to conclude that they are intentionally delaying without good cause.

4. The Defense also represents and submits to this Honorable Court the following regarding expert witness depositions:

a. On April 29<sup>th</sup> 2010, the Oak Ridge Laboratory was given the option to choose any two consecutive days between July 8<sup>th</sup> and July 23<sup>rd</sup> 2010.

While it is our understanding that Assistant State Attorney Jeffrey Ashton is attempting to coordinate these dates, the Defense has not received a response yet as to their availability. (Mr. Ashton expects a response shortly)

b. Doctors David Hall and Neal Haskill are also presently being coordinated which may result in rescheduling other witnesses to accommodate these witnesses. Dr. Haskill's deposition will require the undersigned counsel to travel to Indiana.

c. The undersigned counsel has previously filed notices of unavailability for June 7-11 and June 21-25<sup>th</sup>. These are the first notices of unavailability filed by the undersigned counsel since counsel filed his notice of appearance on July 17, 2008.

5. The Defense respectfully requests the flexibility to move scheduled depositions to accommodate more potential witnesses that may arise as needed.


