AMENDED ADMINISTRATIVE ORDER GOVERNING COURT PRACTICES FOR BODY WORN CAMERAS IN ALL COURTHOUSE FACILITIES WITHIN THE NINTH JUDICIAL CIRCUIT COURT

The purpose of this Administrative Order is to establish guidelines and procedures for law enforcement using body worn camera (BWC) equipment within all courthouse facilities¹. Such regulation is within the Court's inherent authority to take supervisory and administrative actions necessary to implement its judicial functions.

By the power vested in the chief judge under Article V, section 2(d) of the Florida Constitution, section 43.26, Florida Statutes, and Rule 2.215 of the Florida Rules of General Practice and Judicial Administration, effective **immediately**, unless otherwise provided herein, to continue until further order and superseding any provisions in prior Administrative Orders that may be inconsistent, it is **ORDERED**:

1. The Court authorizes on-duty deputies employed by the Orange County and Osceola

¹ For purposes of this Administrative Order, the term "courthouse" means any building or structure in which judicial proceedings may be conducted, including, but not limited to: (1) Orange County Courthouse, located at 425 North Orange Avenue, Orlando, Florida 32801 (including the 23-level courthouse tower commonly referred to as Building C; and the two flanking buildings, Building A occupied by the Public Defender, located at 435 North Orange Avenue, Orlando, Florida 32801, and Building B occupied by the State Attorney, located at 415 North Orange, Avenue, Orlando, Florida 32801); (2) Jon B. Morgan Osceola County Courthouse, located at 2 Courthouse Square, Kissimmee, Florida 34741 (including the Osceola County Historical Courthouse, located at 3 Courthouse Square, Kissimmee, Florida 34741); (3) Thomas S. Kirk Justice Center, located at 2000 East Michigan Street, Orlando, Florida 32806; (4) Orange County Booking and Release Center, located at 3855 South John Young Parkway, Orlando, Florida 32839; (5) Orange County Branch Courthouse – Apopka, located at 1111 North Rock Springs Road, Apopka, Florida 32712 (limited to those spaces specifically used for court functions); (6) Orange County Branch Courthouse – Ocoee, located at 475 West Story Road, Ocoee, Florida 34761 (limited to those spaces specifically used for court functions); and (7) Orange County Branch Courthouse – Winter Park, located at 4037 Metric Drive, Winter Park, Florida 32792.

County Sheriff's Offices to activate BWC equipment to record contact with an individual(s) in accordance with the respective Sheriff's Office governing polices when: (1) there is a disturbance in the courtroom that may impede the function of the courtroom², or (2) when a deputy, in their professional opinion, determines that they will be required to engage in a law-enforcement related encounter. In such situations, a deputy may activate their BWC equipment until such time as, in their professional judgment, the incident has concluded.

- 2. BWC equipment shall not be activated in a courtroom during judicial proceedings except for those situations specified in paragraph 1. Unless dictated by operational need, the BWC equipment shall not be on silent mode; when activated, the light plus beep must be visible/audible for on-duty deputies assigned to court security wearing BWC equipment in a courthouse or courtroom.
- 3. Any deputy who activates BWC equipment in a courtroom must notify the presiding judge as soon as practicable and no later than the end of the court session. Additionally, Sheriff command must timely notify Court Administration, the Chief Judge or his/her designee when there is an activation.
- 4. Within one (1) business day of the emergency incident, the deputy or their supervisor shall provide to the presiding judge a written report of the circumstances surrounding the activation of the BWC equipment, including the times of activation and deactivation and an explanation of the deputy's actions.
 - 5. Each Sheriff's Office of the Ninth Judicial Circuit is the custodian of any records captured

² As used herein, the word "courtroom" includes courtrooms, hearing rooms, jury services assembly rooms, jury deliberation rooms, any location where jurors gather without regard to duration, and any other places used to conduct court proceedings, unless specifically stated otherwise.

by a deputy's BWC. A recording made in a courthouse or courtroom in connection with law

enforcement activity shall not be released to anyone outside the Court and the Sheriff's Department

with which the deputy is associated unless the recording has been provided to the Chief Judge or

designee in advance and with sufficient time to determine if there is confidential or exempt

material contained within the recording. If BWC equipment records and stores any portion of a

court proceeding, confidential, exempt or privileged material may not be released without Chief

Judge or designee consent.

6. Except as provided above, activation of BWC equipment by any law enforcement officers

working or conducting business in the court is prohibited inside all courthouse facilities and

courtrooms.

7. Administrative Order 2023-04 is vacated and set aside except to the extent that it has

been incorporated and/or amended herein. Vacating an Administrative Order that vacates a prior

Order does not revive the prior Order.
