**ORDER SETTING STATUS HEARING* TO DETERMINE DATE OF
TRIAL AND/OR NEED FOR CASE MANAGEMENT CONFERENCE**

THIS CAUSE came before the Court on a Notice That Case Is At Issue,¹ pursuant to *Fla.R.Civ.P.* 1.440(a) and Notice For Trial pursuant to *Fla.R.Civ.P.* 1.440(b), and the Court after having reviewed this matter, and being otherwise familiar with the Court file, it is

ORDERED AND ADJUDGED that a **Status Hearing** is hereby scheduled on _____, at _____ a.m. in Courtroom 5C, Osceola County Courthouse, Kissimmee, FL for the purpose of:

- (1) Confirming that the case is ready to be set for trial, and/or
- (2) Setting this matter for trial on the Court's Docket, and/or
- (3) Scheduling a Case Management Conference, which will require all trial counsel to attend in person.

*Attorneys and/or *pro se* litigants **do not** need to appear, if the parties stipulate in advance to a trial period and notify the Court in writing by email at CTJABG1@OCNJCC.ORG. Upon receipt, the status hearing will be cancelled and the trial order will be issued by the Court.

The attorneys who will try the case must attend this status conference and are to have their calendars available so that the trial and/or case management conference can be scheduled. A party may appear by phone if a motion is filed and granted.

¹*Fla.R.Civ.P.* 1.440(a) does not require that discovery be completed to be "at issue." Further, *Fla.R.Civ.P.* 1.440(c) allows the Court to set the matter for trial. This order constitutes the "Notice" required in 1.440(c) to set this action for trial.

All counsel and *pro se* litigants are advised that the purpose of this conference is to set a date for trial that is far enough in advance to allow discovery and trial preparation to be completed prior to trial, and to make certain that conflicts do not exist with the date chosen for trial. Accordingly, continuances of the trial date requested hereinafter will only be granted where good cause is shown and the event necessitating the request could not have been anticipated.

All parties are advised to refer to the SUMMARY OF DEADLINES on the Court's website to reference deadlines for pretrial and trial, set forth by the Court.
